



## **Conflict of Interests**

The British Journal of Diabetes is proud of its reputation and fiercely guards and protects its independence. Our strict policy is that editorial independence, decisions and content should not be compromised by commercial or financial interests, or by any specific arrangements with advertising clients or sponsors. Our policy is to disclose such arrangements where there is any risk of a perception of compromise.

### **Authors**

The British Journal of Diabetes requires that all authors disclose any potential sources of conflict of interest. Editors may use information disclosed in conflict-of-interest statements as a basis for editorial decisions.

For all manuscript submissions, regardless of article type, all contributing authors must complete a declaration of interests form at the time of submission and within the acknowledgments section of the manuscript itself. If authors have no relevant conflicts of interest to disclose, this should also be declared. It is the responsibility of the corresponding author to review this policy with all authors and collectively to disclose with the submission ALL pertinent commercial and other relationships.

Examples of potential conflict of interest include:

- Employment, membership on the board of directors, or any fiduciary relationship with a third-party entity engaged in the development, manufacture, or sale of pharmaceutical or medical devices, supplies, or information;
- Ownership of stock or receipt of honoraria, travel or meeting expenses, or consulting or review fees from a third-party entity, as described above;
- Receipt of financial support or grants for research from a third-party entity, as described above;
- Holding patents or receiving royalties related to the development of pharmaceutical or medical devices, supplies, or information;
- Receipt of writing assistance, medicines, medical devices, materials, equipment, or administrative support from a third-party entity, as described above;
- Membership on a scientific advisory panel or other standing scientific/medical committee;
- Receipt of payment or honoraria for author contributions or author designation; and
- Any other relationships that readers could perceive to have influenced, or that give the appearance of potentially influencing, the content of the submitted work.

If the study was sponsored by a third party, authors should describe the role of the study sponsor in study design; collection, analysis, and interpretation of data; writing the report; and the decision to

submit the report for publication. If the supporting source had no such involvement, the authors should so state.

We recognise that some authors may be bound by confidentiality agreements. In such cases, in place of itemised disclosures, we require authors to state: "The authors declare that they are bound by confidentiality agreements that prevent them from disclosing their competing interests in this work."

Peer reviewers are able to request to see declarations of interest.

## **Peer reviewers**

We invite peer-reviewers to exclude themselves in cases where there is a significant conflict of interest, financial or otherwise. However, just as financial interests need not invalidate the conclusions of an article, nor do they automatically disqualify an individual from evaluating it. We ask peer-reviewers to inform the editors of any related interests, including financial interests as defined above, that might be perceived as relevant. Editors will consider these statements when weighing reviewers' recommendations

## **Editorial Team**

Editorial Board Members, Guest Editors and Editors are required to declare any competing interests and may be excluded from the peer review process if a competing interest exists. In addition, they should exclude themselves from handling manuscripts in cases where there is a competing interest. This may include – but is not limited to – having previously published with one or more of the authors, and sharing the same institution as one or more of the authors.

Where an Editor, Guest Editor or Editorial Board Member is on the author list we recommend they declare this in the competing interests section on the submitted manuscript. If they are an author or have any other competing interest regarding a specific manuscript, another Editor, Guest Editor or member of the Editorial Board will be assigned to assume responsibility for overseeing peer review. These submissions are subject to the exact same review process as any other manuscript.
