You also warrant that the Article does not contain anything which is defamatory, illegal, or infringes anyone's copyright or other rights. You agree to indemnify us against any claims in respect of the above warranties and this indemnity shall survive the termination of this Agreement.
4. You assert your Moral Right to be identified as the Author(s). We will respect your rights as the Author(s). That is, we will make sure that your name(s) is/are always clearly associated with the Article, and we will not make any substantial change to your Article without consulting you. When the Article is accepted, we undertake to publish it as soon as we reasonably can. On publication, we will send you a free digital copy. We will take all reasonable steps to maximise the visibility of the Journal, and of your Article within it.
5. You declare that any person named as co-author of the Article is aware of that fact and has accepted being so named.
6. Copyright remains yours, and we will acknowledge this in the copyright line which appears on your Article. However, you authorise us to act on your behalf to defend your copyright if anyone should infringe it, and to retain half of any damages awarded, after deducting our costs.
