






Significant proportion of NTN posts are unfilled at present

#### Overview (1)

- The survey appears to continue to give a reasonable ascertainment of numbers in post
- The numbers of new appointments was less than last year and a bigger reduction in acute medicine posts
- Downward trend over the last since 2004 except for last year (2009-10)

#### Overview (2)

- Uncertainty about the actual numbers of expected new CCT holders in the coming years
- Retirement vacancies do not look likely to vary much in the coming years
- The rate of creation of new posts will continue to determine the overall balance
